## Greetings from the National Office...

The Executive Committee and Board of Directors had their mid-year meeting in St Louis, January 11-14. Hard working yet fun filled hours discussing: 2007 Convention, SWIMMER Magazine, world championships, strategic initiatives for technology services, online event entry, LMSC issues, standardization of USMS/LMSC registration fee, club development task force, policy manual task force, online registration, executive director search, FINA, charitable solicitation policy, USMS strategic plan, evaluation of our organizational structure, committee effectiveness. complete minutes of these meetings can be found on the USMS website.



Swimming—did you swim the One Hour Swim? Did your club/workout group do anything special to motivate you to swim further? My workout group—Granite State Penguins—encourages everyone to participate. The event is spread out over numerous days during our morning time slot, with 6-8 swimmers swimming at once. An event referee (aka – Vanna) patrols the deck with yardage and time cue cards so swimmers know where they're at. The "Steady Penguin" award was introduced in 1999 and is given to the swimmer with the smallest average standard deviation between splits. New this year is the team "relay" competition in which we were split up into three teams, with members of each team selected so that the total yardage from past year(s) performances is the same across the teams. It is a battle. Results are e-mailed out each day and there is some trash talking. The winning team gets a "Life is Good" swimmer t-shirt. It has been very motivating and actually made the event fun.

Rule Books & LMSC Handbooks have been shipped (both are posted on the USMS website). Planners are at the printer and will be sent out soon. The Directory is having its finishing touches applied and will be sent to the printer soon. ### Insurance Certificates Online

Proof of insurance for USMS Clubs.

A location your club is swimming at might ask you to be added as additional insured to your policy. You can now process this request yourself directly over the Internet 24 hours a day, 7 days a week. Please call Carmen Van Boening at 1-800-777-4930 # 10 with any questions. Make sure that you are online when calling, so Carmen can guide you through the program

1. Enter your User ID - 2 digit LMSC number, a dash (-), your 3 digit club number (Example - xx-xxx)
2. Enter your Password – MASTERS (in capital letters)
3. Click on “Deliver Certificates” in the middle of the screen
4. Select the “2007 Masters Certificate” and hit continue
5. Either:
  - a. Select a Recipient and hit “Continue”
  - b. Change a Recipient by clicking on the blue name. The field will open and you can edit the information. Make sure to save the information, select the Holder and hit “Continue”
  - c. Add a new Recipient. Click on “New Recipient”, a window opens. Enter Name, Address, City, State, ZIP, Country of the location that asked you for this Certificate.

Choose a delivery method. You have the option to e-mail, fax, US-Mail, or save only. Depending on the method you choose you need to enter the information in the appropriate field. (Example - if you choose e-mail you will need to enter the e-mail address).

Click “Save”, Select the Recipient and hit “Continue” *Please do not add your own swim club name or any individual person as recipient. It has to be the facility or company that asked you for this Certificate and you always need the facilities address, no matter which delivery method you choose.*

6. Review Information and hit continue.
7. Review Delivery Method and hit continue.
8. This is the last screen. For a copy of the Certificates for your files check the box and a copy of the certificate will be e-mailed to you. A copy will be sent to the main e-mail address that is registered with United States Masters Swimming.
9. Hit Deliver Now and you will be brought back to the beginning and this means that your certificate was sent out. The system may take up to 48 hours to deliver the certificate.

### USMS Planners Now Available!

The 2007 USMS Planners are now available at the USMS National Office. The Planner is an invaluable resource for keeping track of your swimming activities and progress, as well as a calendar for recording workouts and schedules. Valuable coupons from our sponsors, found in the back of this Planner will save you money on your swimming necessities.

The Planner is free, you just have to send a self addressed stamped (\$.63) envelope (5 x 7) and upon receipt, a Planner will be sent right out to you.

### 2009 Long Distance National Bid Forms

Bid forms for the 2009 USMS Long Distance Championships (attached with this newsletter) have been e-mailed and must be returned to Marcia Cleveland ([longdistance@usms.org](mailto:longdistance@usms.org)) no later than Friday, August 3, 2007. Forms are also available by emailing Marcia or by going to the Long Distance web site ([www.usms.org/longdist/](http://www.usms.org/longdist/)). Site/host selection for the 2009 events will occur at the 2007 USMS Convention in Anaheim, but committee review and discussion will take place prior to convention. The Long Distance Committee encourages all interested organizations to bid, particularly those that have not previously hosted a national championship.

Out-of-area bids for open water events will not be considered if there are qualified, in-area bids, but this is often not the case. The last page of the bid form contains the area system for 2009. Postal events are not subject to area restrictions, and you may use one form to bid for more than one postal event.

### USMS CLUB IN A BOX

USMS has made Club / LMSC development and membership a priority, and have allocated funds to promote a program called “USMS Club In The Box”. This program will assist LMSCs and Clubs in the development of their adult aquatic fitness programs. ### History & Archives Committee Request

The USMS History and Archives (H&A) Committee and the USMS National Registrar are requesting help from all current and former masters swimmers, LMSCs, LMSC Registrars, and keepers of LMSC documents. In order for us to reconstruct, verify, and finalize the pre-1986 registration database, we need to locate any LMSC registration files (paper copies or electronic files) for 1972-1980 when we were AAU Masters, for 1981 when we were USMS but our registration was handled by AAU, and for 1982 to 1985. There were roughly 12,000 total registrations in 1982 and that number grew to 27,000 by 1987.

Please note that all registration data will be kept confidential with restricted access. If you have any information or can supply the requested documents, send an email to H&A Chair Barbara Dunbar, Archives at usms dot org and remember to convert at and dot to the @ and . characters before emailing.

For the period from 1972-1985, we continue to seek LMSC lists of clubs, club lists from Nationals or regional brochures and results, or any other source of national club lists such as the USMS Handbook. In addition, we are looking for the second part or the update to "The Master List for 1974 compiled by The Masters Team, ACC Gym, Cooperstown, NY" which was a National Masters mailing list summarized in three (3) sections, the AAU zones for the country.

## Long Distance Postal Series

What the Heck is the Postal Series and How do I Participate In It?

Sometime during October 2002, there I was in a pool in Connecticut, slogging it through several pace 100's, preparing myself for the 6000 yard postal event, the final leg of my swimming all five postal events that year. When you're doing 100's ad nauseum, your mind starts to wander and being no different from the norm, mine started thinking, "I wonder what is the total fastest combined Postal Series ever done?" After another flip turn knocked some sense into me, I started to think, "Heck, forget about the fastest, how 'bout just doing them at all??? That's a HUGE accomplishment in itself. Let's give everyone who does all five Postals some sort of gold star."

I was the Vice Chair of the USMS Long Distance Committee at the time and the Chair, Peter Crumbine, was on vacation for the next few days. By the time Peter returned to real life, our committee not only had consensus on establishing this Postal Series but we had all but finalized the Postal Series Logo!

So what are the five events you need to participate in if you're destined for this proverbial 'gold star'? Actually, you receive a patch that says, "Postal Series", a nice letter from the USMS LD Chair, and your name on "The List" that appears in USMS Swimmer. Believe me, almost all 43,000 USMS members read THAT LIST.

1. In January you need to do the One Hour Swim
- 2 & 3. Sometime between May 15 and September 15 th, you need to do both the 5000 meter swim and the 10,000 meter swim, each in a 50M pool.
- 4 & 5. Between September 15th and November 15th, you need to do both the 3000 yard swim and the 6000 yard swim, each in a 25 yard pool.

Since it's official inception in 2003, only 20-40 USMS members annually participate in this series, including our own Skip Montanaro and John Martin in 2005, plus yours truly, in 2004 & 2005, and plans for 2007. Skip, John, Nadine Day, and I even combined to establish a new USMS national record in the 4 x 10K Mixed Relay, each of us earning All-American status, to boot!

If you want the entries for each of these events, please visit the Long Distance page of the USMS website at [www.usms.org/long-dist](http://www.usms.org/long-dist). Most importantly, you'll need to get crackin' on the One Hour Postal swim since it MUST be swum by January 31 st. If you are interested, we can get a group together to assist one another in the timing, since for each of these events, you must have a timer who gets your split every 50 yards in the One Hour, 3000, and 6000, and every 100 meters in the 5K & 10K.

I'd love to have your company in this Postal Series this year. It's a big undertaking but the sense of accomplishment lasts forever! Ask Skip about it sometime.

## RULES CORNER

Mini rule books are also available (\$3 each). The rule book is also available for viewing, downloading, or purchase at [www.usms.org](http://www.usms.org).*

All rule numbers below reference the 2007 USMS Rule Book.

**Question:** "If I swim the 50 free and just miss the record, can I ask to reswim it later in the meet in another attempt to break the record?"

**Answer:** No. Except for postponement (102.13.3, pages 12-13) there are no provisions for reswimming a race. A swimmer would have an opportunity to swim the 50 free again by swimming the leadoff leg of a relay. Record attempts can also be made during initial distances of longer events (105.3.7, page 38) as can official times for Top 10 (105.2.2, page 38) and official times for all purposes (103.13.1, .2, and .3, pages 24-25).

**Required Officials at a Meet:** The minimum number of officials required at a meet is: one referee, one starter, two stroke and turn judges, and two timers per lane if automatic timing is not being used (one timer per lane if automatic timing is used). (103.1, page 15)

One official may serve two positions as follows: The referee may also serve as a stroke and turn judge but not as a starter. The starter may also serve as a stroke and turn judge but not as a referee (103.1.1, page 15).

The referee at each meet shall be certified: as a referee, a starter, or a stroke and turn judge. If, among the officiating crew on deck, there is only one official who is certified, that official must be the referee (103.2, page 15). Note that national championship meet requirements are more stringent and require more officials who are certified (104.5.10, page 36).

**Pool Measurement:** Your times will not count for Top 10 Records, or any official purpose unless the pool has been measured and it's long enough (103.13.4, page 25 and 105.1.5, .6, and .7, page 37). If a pool with a moveable bulkhead already has a pool length certification for all lanes on file with USMS or USA Swimming, then measurement of the two outside lanes and a middle lane must be confirmed at the end of each session of the meet (105.1.7C, page 37).
